




Dear Secretary Browning:

The U.S. Department of the Treasury's Office of Foreign Assets Control ("OFAC") administers a comprehensive economic sanctions program that targets the property and interests in property of any person designated pursuant to the Foreign Narcotics Kingpin Designation Act ("Kingpin Act"), 21 U.S.C. §§ 1901-1908. The Kingpin Act became effective on December 3, 1999, and is implemented by the Foreign Narcotics Kingpin Sanctions Regulations, 31 C.F.R. Part 598, and the Reporting, Procedures and Penalties Regulations, 31 C.F.R. Part 501 (collectively, the "Regulations").

OFAC has the authority to name individuals and entities as Specially Designated Nationals ("SDNs") pursuant to the Kingpin Act and the Regulations. Property and interests in property of an SDN that are within the United States or within possession or control of any U.S. person are, with limited exceptions, blocked. Also, with limited exceptions, any transaction or dealing by a U.S. person, or within the United States, in property or interests in property of an SDN is prohibited. 
