- B. Since the first step in the lodestar process requires the court to determine the number of hours reasonably expended on this litigation. The court finds that the reasonable number of hours expended on behalf of Robert L. Fast in this litigation to which he is responsible was twenty hours.
- C. Pursuant to <u>ROWE</u>, the second half of the equation requires this Court to determine a reasonable hourly rate for the services performed by Stephen H. Butter, P.A.
