

After due Notice of Repeat Violation and Hearing to the RESPONDENT(S), at a further public hearing before the SPECIAL MAGISTRATE on 7, 20, 20, an AFFIDAVIT OF NONCOMPLIANCE bearing the date of 7, 20, 20, was filed with the SPECIAL MAGISTRATE by the code enforcement officer, which AFFIDAVIT certifies under oath that a repeat violation of the prior order, more particularly described in Exhibit "B" attached hereto, had occurred and the required corrective action was not taken as necessary; and wherein the RESPONDENT(S) was/were given the opportunity to testify and submit evidence.
